- DOS 6.0 or higher and Windows\*\* 3.1X or Windows95\*\*

### Installing your modem

Following are instructions for installing the IBM ISA V.34 HPC Data/FAX modem. Please also refer to the documentation that came with your computer to install the modem.

**Note :** The illustration shows the modem installed horizontally in the slot. In some computers, the modem may be inserted vertically in a slot.

Except for a screwdriver, everything you need to install your new modem is included in this package. However, you may need additional information about the current settings on other adapter cards that are installed in your computer. Make sure you have the documentation that came with your computer ready for reference purposes.

# Installing the Modem Card



IBM ISA V.34 HPC Data/FAX Modem

- 1. Turn off the computer system and remove any power connections.
- 2. Remove the computer cover as described in the computer's operation manual.
- 3. Using a small flatblade screwdriver, remove the slot cover from an empty expansion slot. Retain the screw and store the slot cover for future use.
- 4. To avoid static electricity (which can damage hardware), touch the metal frame of the computer system for at least 2 seconds before handling or installing peripheral cards.
- 5. Touch the anti-static bag containing the IBM ISA HPC Modem to the metal frame of the system, then carefully remove the card from its bag.
- 6. Hold the IBM ISA HPC Modem card on the top edge and align the edge connector over the chosen expansion slot.
- 7. Push the card straight into a slot until firmly seated. Do not wiggle the card from side to side or force the card into the slot. Remove the card and try again if necessary.
- 8. Secure the metal bracket in place with the screw from the removed slot cover.
- 9. Note: Not all computers have the Wake Up On Ring feature, see your computer's reference manual for information about your computer's features. If you have Wake Up On ring and want to install the Wake up on Ring cable, go to Wake Up On Ring Connection on next page.
- 10. Replace the computer cover.

#### Do not turn on the computer with the cover off.

11. Reconnect the power and any other cables that were removed.

Note: ensure telephone line is connected to correct connector on modem card.

#### Wake-Up on Ring Connection

If your system is capable of performing the Wake-Up on Ring feature and you want to use it, install the Wake-Up on Ring cable as follows.



- 1. Locate the JP24 connector on the ISA HPC Modem card. JP24 is located close to center of the card.
- 2. Connect the two-pin connector end of the Wake-Up on Ring cable contained in your ISA HPC Modem package to connector JP24. The Wake-Up on Ring cable is "keyed" to ensure proper connection.
- 3. Connect the cable's four-pin flat connector to the Modem Ring Detect connector on the system board. For further information about the location of the Modem Ring Detect connector and how to use the Wake Up On Ring feature, refer to the documentation that came with your computer.
- 4. Replace the computer cover.

#### Do not turn on the computer with the cover off.

5. Reconnect the power and any other cables that were removed.

Note: ensure telephone line is connected to correct connector on modem card.

#### Installing your Modem Software

This section provides instructions for installing the IBM ISA V.34 HPC Data/FAX modem software. Please install the software for the operating system you use.

#### Windows 3.1 Installation

The IBM ISA V.34 HPC Data/FAX modem software is designed to operate under Windows 3.1x enhanced mode. After installing the software, you can obtain additional information from the AT CMD and README files supplied in the IBM HPC program group.

The installation procedures are:

- 1. If off, power on your computer, start Windows, if not already started.
- 2. Insert the IBM ISA HPC modem Windows 3.1 Installation diskette into diskette drive A:
- 3. From the Program Manager, select the **File** pull down menu located at top left of Program Manager.
- 4. Select Run...
- 5. Type A:\Setup and select OK.

Note: upper or lower case will work

Follow the instructions for the setup process.

#### Windows95 Installation

The IBM ISA HPC diskette for Windows95 contains two additional files you may find useful. One is a summary of the supported AT commands (ATCMDS.DOC) and one is a README.TXT file with any last minute information.

To setup the IBM ISA V.34 HPC Data/FAX modem for Windows95, you must complete the following installation procedures.

Register HPC modem onto the Windows95 modem registry database.

Setup COM port for IBM ISA HPC V.34 Data/FAX modem:

- 1. If off, power on your computer, start Windows95.
- 2. Insert IBM ISA HPC modem Windows95 Installation diskette into diskette drive A:
- 3. Click the **Start** button.
- 4. Highlight the **Settings** item.
- 5. Click the **Control Panel** item to open the Control Panel folder.

Double click Add New Hardware icon on the Control Panel.

- 13. Click **Finish** to end the Port installation.

- 7. Windows95 system will show the modem models. Select **IBM ISA HPC modem**.
- 8. Click **NEXT>** to confirm the choice.
- 9. From the **PORT MENU** select **IBM HPC Communication Port** to use with the modem.
- 10. Click **NEXT>** to confirm the choice. Files will be copied to your system.
- 11. Location Information is displayed, fill in the information and click next.
- 12. Click **Finish** to complete the modem installation.
- 13. You have completed the drivers and HPC modem registry key installation. Windows must restart to activate the modem.
- 14. Note: After you restart windows, you can use the modem manager in the Windows 95 control panel to verify the HPC modem is working. From the modem **diagnostic** folder, select and run **more info** to see if HPC modem is responding.

#### **Testing Your Modem**

Refer to the Application Software's Installation Manual to load the communications software you will be using.

- 1. Turn on your computer.
- 2. Start your communication software and be sure it is in the command mode. This is also known as terminal mode.
- 3. Setup your communication software to 19200 and the communication port your modem is using.
- 4. If the port opened properly, go to the next step. Otherwise, check if you have any other communication software trying to use the same port. If so, close that software. If not, switch to a different COM port.
- 5. Type **AT&F** and press **enter**, you should see an **OK** response. If nothing happened at this point, this indicates that the modem is not getting the proper IRQ.
- 6. Type AT\N1 and press enter
- 7. Type ATE1 and press enter
- 8. Type ATS18=n and press enter

NOTE: n is the number of seconds (30-255) you want the test to last.

- 9. Type **AT&T1** press **enter**. You should see **CONNECT nnnnn** (n is the connect speed you selected) displayed on your screen. After the CONNECT message, the modem is in the data mode. You can type any character on your keyboard and see them displayed on your screen.
- 10. When the time you specified in register S18 expires, you see **No Carrier** displayed on your screen.
- 11. Type AT&F and press enter, you should see an OK response.

#### **Appendix B. Help and Service Information**

Before calling, please prepare for your call by following these steps.

#### **Step 1: Troubleshooting**

The modem was completely tested for proper operation at the factory before packaging for shipment. If the modem does not respond to the **AT** commands described in *Testing the modem*, please try the following:

- Ensure that the modem is properly seated in your computer by removing and re-inserting the modem.
- Verify that the COM port specified in your communications software is the same as the COM port to which your modem is set..
- Ensure that the communications software is installed properly. Follow the installation instructions in the communications application manual carefully, and check the documentation for any additional information pertaining to your system.

#### **Step 2: Preparing for the Call**

To assist the technical support representative, have available as much of the following information as possible:

- Option name, description and serial number (if any)
- Order and or Field Replaceable Unit (FRU) part numbers
- Proof of purchase
- Computer manufacturer, model, serial number (if IBM) and manual
- Exact wording of the error message (if any)
- Description of the problem
- Hardware and software configuration information for your system
- If possible, be at your computer. Your technical support representative might want to walk you through the problem during the call.

#### **Step 3: Placing the Call to IBM**

#### **Statement of Limited Warranty**

The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you originally purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. If you have any questions, contact IBM or your reseller.

### Warranty Period\*: Three (3) years

#### **Production Status**

Each Machine is manufactured from new parts, or new and used parts. In some cases, the Machine may not be new and may have been previously installed. Regardless of the Machine's production status, IBM's warranty terms apply.

#### The IBM Warranty for Machines

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications. The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your receipt is the Date of Installation, unless IBM or your reseller informs you otherwise.

During the warranty period IBM or your reseller, if authorized by IBM, will provide warranty service under the type of service designated for the Machine and will manage and install engineering changes that apply to the Machine.

IBM ISA V.34 HPC Data/FAX Modem

For IBM or your reseller to provide warranty service for a feature, conversion, or upgrade, IBM or your reseller may require that the Machine on which it is installed be 1) for certain Machines, the designated, serial-numbered Machine and 2) at an engineering-change level compatible with the feature, conversion, or upgrade.

Many of these transactions involve the removal of parts and their return to IBM. You represent that all removed parts are genuine and unaltered. A part that replaces a removed part will assume the warranty service status of the replaced part.

If a Machine does not function as warranted during the warranty period, IBM or your reseller will repair it or replace it with one that is at least functionally equivalent, without charge. The replacement may not be new, but will be in good working order. If IBM or your reseller is unable to repair or replace the Machine, you may return it to your place of purchase and your money will be refunded.
